The evidence here supports a finding that Phillips exercised control over the property. Plaintiff's brief cites as proof of its claim of excessive force an incident that occurred on March 20, 1993, where he was stopped for speeding by Deputy Peters. At that time, Deputy Peters ordered the passenger to "get out" and he removed Richard Phillips from the car. We will not address this incident in detail for the reason that it is disposed of on other grounds. Suffice it to say that any use of force was directed to a person not an owner of the property, and therefore, the incident is not admissible to show probable cause or to establish a defense to a charge of theft of property. Plaintiff also contends that the evidence shows that he was "arrested" for theft of property. He cites authority to the effect that a person is "arrested" when he has stopped his automobile, the officer notifies him that he has stopped him and asks him what he is doing in the area. When the person informs the officer that he is taking a walk, the person is "arrested" for resisting arrest. This rule was established for situations where the officer has the person stopped for a traffic offense where there is no probable cause to believe the person committed a crime other than the traffic offense. To apply this rule to a person who has stopped his automobile in a public street and has the keys in his hand, we must hold that there is probable cause for the officer to stop the vehicle
